Following this event, planning applications for these sites will be prepared and submitted to Wandsworth Council as the Local Planning Authority (LPA) for consideration. At this point, you will be able to view the complete set of planning application documents, all supporting studies and assessments in full, and make any comments directly to the LPA. If you are not comfortable navigating websites or do not have internet access, please give us a call and we will do our best to assist you with what you need.

Once the applications are submitted, the LPA will consider these comments and receive recommendations from independent consultants and statutory consultees, who will provide technical expertise in assessing matters such as the proposed arrangements for parking, access and safe movement around the sites, daylight, noise, and infrastructure requirements.

We are inviting comments on the detailed proposals up to Friday 6 October 2023 (11:59pm).

#### August 2023

#### Late 2023

Target submission of our planning applications to Wandsworth Council as the Local Planning Authority (LPA)

#### Early/Mid 2024

We expect to receive a decision from the LPA on the applications submitted for these proposals

#### Late 2024/early 2025

Estimated start date for construction works subject to planning approval being granted
