The information below is based on 147 responses. 95% of the feedback has been provided by local residents, with a balanced representation of genders and over half of responses coming from the 35-54 age groups. This report captures feedback from the 28 April 2023 to 31 May 2023 consultation period.

- 5. Comment about the consultation process or project team (8%)
- 6. Does not consider that the proposals will provide any benefits to the existing Ashburton South community (7%)
- 7. Concern that the feeling of congestion will increase (6%)
- 8. Concern for parking realities (5%)
- 9. Against change to existing green and open areas (5%)
- 10. Existing properties and areas need to be repaired/maintained first (4%)
